The purpose of this report is to summarize the data and goals for your project. Please review the information in this report carefully and report if any additional information is known at project start or if any of the information should be changed or corrected.

Client has a desire to learn more about her direct ancestor Ebenezer Hemingway who was the subject of a D.A.R. application filed during 1928 (No. 250015). Client used the identity of Ebenezer Hemingway as a legacy for her D.A.R. application that was accepted by the D.A.R. The application filed by the original applicant Esther T. Davis traced her direct line back four generations to Ebenezer Hemingway.

Little specific information was reported about the identity of Ebenezer Hemingway like his specific places of birth, marriage and death. It was said that Ebenezer Hemingway was born circa 1780 and died in 1839. His wife Ruth Golds was noted to have died during 1854, but her date of death was not listed. The references used by Esther T. Davis did not report a specific English place of origin for Ebenezer Hemingway and it also did not report the identities of his parents. A copy of this D.A.R. ## **Summary of Research Recommendations:**

Without a specific place of English origin for Ebenezer Hemingway, and without the identities of the parents to our subject, genealogist recommends applying up to one hour and forty-five minutes of research time completing a digital collections survey on the direct ancestors of Esther E. Davis with a goal to verify and prove her direct line back to Ebenezer Hemingway and his parents. It will be important to collect copies of original documentation on this line to determine if any evidence can be found that will report a specific place of English origin for Ebenezer Hemingway or his parents.

Digital Collections Survey is a term we use to describe a research survey that exhausts all available collections of documents that are published online including but not limited to Ancestry.com and other premium information service databases. Copies of original documentation may include census, vital, military, probate, land and church records; secondary documentation may include copies of record transcriptions, record index entries and published genealogies.
