



## Research Results Report Tara A. Fantauzzi, Professional Genealogist

### Summary of Correspondence Results:

#### 1. March 2019 - Correspondence, .75 hours

- Submitted request to the U.S.C.I.S. to complete an index search to locate C-File or A-File for Joseph 'Giuseppe' Arnao - RESULTS RECEIVED
  - No record found after several variations of surname searched
- Submitted Request to Paolo Campagna to obtain copy (1) historic copy (copia integrale) of an original Italian civil birth record for Joseph 'Giuseppe Maria' Arnao, (2) certified Italian birth extract for Joseph 'Giuseppe Maria' Arnao and (3) historic copy (copia integrale) of an original Italian civil marriage record for Vincenzo Arnao and Giovanna Romano - RESULTS RECEIVED
  - The correspondence work yielded one positive result; specifically, a copy of an original historic copy (copia integrale) of an original Italian civil birth record for Joseph 'Giuseppe' Arnao and (2) certified Italian birth extract for Joseph 'Giuseppe Maria' Arnao. A hard copy of the certified Italian birth extract was mailed to genealogist and when it is received it will be forwarded to client for use as part of her Italian dual citizenship application.
  - The City of Palermo was unable to find a marriage record for the parents of Joseph 'Giuseppe Maria' Arnao named Vincenzo Arnao and Giovanna Romano after a search was completed of marriage records recorded in Palermo from 1886-1915.

#### 2. August 2019 - Correspondence, 1.25 hours

- Submitted a request to the U.S.C.I.S. to obtain a certificate of non-existence for Giuseppe 'Joseph' Arnao because no C-File or A-File was found after an index search was done
- Submitted a request to the Jefferson County Orphan's Court to obtain a copy of an original birth record for Christine Domiano - PENDING
- Submitted requests to N.A.R.A. to obtain certified copies of original 1930 and 1940 Federal population censuses for the household of Joseph 'Giuseppe Maria' Arnao - PENDING



### 3. September 2019 - Correspondence, .5 hours

- Submitted request to the Monroe County Clerk's office to search for naturalization paperwork related to Vincenzo 'Vincent' Arnao; if no record found requested certified letter be submitted to prove no record was found by that office
- Submitted request to the U.S.C.I.S. to complete an index search to locate C-File or A-File for Vincenzo 'Vincent' Arnao

### 4. October-December 2019 - Correspondence, .25 hours

- Submitted request to the Chautauqua County Clerk's office to search for naturalization paperwork related to Vincenzo 'Vincent' Arnao;
- Received response from the Monroe County Clerk's office in the form of a certified letter to prove no record was found after a thorough search was completed by their office to find naturalization paperwork for Vincenzo 'Vincent' Arnao
- Received response from the Chautauqua County Clerk's office and a copy of the naturalization paperwork for Vincenzo 'Vincent' Arnao was found; it reported he became a naturalized citizen on the 18th of February 1918, Certificate No. 822589
- Received response from the U.S.C.I.S. that a C-File was found for Vincenzo 'Vincent' Arnao, specifically C-File C822589
- Received response from the U.S.C.I.S. and obtain a certificate of non-existence from for Giuseppe Arnao
- PENDING from August 2019 - 2 requests to N.A.R.A. to obtain certified copies of original 1930 and 1940 Federal population censuses for the household of Giuseppe Maria 'Joseph Mario' Arnao; completed follow up
- PENDING from August 2019 - 1 request to the Jefferson County Orphan's Court to obtain a copy of an original birth record for Christine Domiano; completed follow up
