



## Research Recommendations Report Tara A. Fantauzzi, Professional Genealogist

### Summary of Research Recommendations:

#### **(1) Identity of Edward J. McLaughlin**

Genealogist recommends applying up to fifteen minutes of correspondence time requesting a copy of an original Irish birth registration for Edward McLaughlin reported to have been born on the 4th of October 1872 in Kilmacrenan, County Donegal, Ireland from the Irish General Registration Office. The search and copy fees due to the Irish G.R.O. will be up to \$10.

*Correspondence Time is a term we use to describe research tasks that involve direct contacts with government agencies, historical societies, or other entities to submit requests for documents; often including the completion of formal request forms, emails, or mail correspondence. Correspondence tasks are billed at half our normal research rate.*

#### **(2) Identity of Elizabeth M. McNulty**

Genealogist recommends applying up to fifteen minutes of correspondence time requesting a copy of an original Irish birth registration for Elizabeth M. McNulty reported to have been born on the 26th of March 1875 in County Down, Ireland from the Irish General Registration Office. The search and copy fees due to the Irish G.R.O. will be up to \$10.

#### **(3) Identity of James Patrick White**

Genealogist recommends applying up to fifteen minutes of correspondence time requesting a copy of an original English birth registration for James Patrick White reported to have been born on the 30th of May 1866 in Liverpool, Lancashire, England from the English General Registration Office. The search and copy fees due to the English G.R.O. will be up to \$10.

#### **(4) Identity of Catherine Joyce**

Genealogist recommends applying up to fifteen minutes of correspondence time requesting a copy of an original Irish birth registration for Catherine Joyce reported to have been born on the 31st of August 1875 in County Waterford, Ireland from the Irish General Registration Office. The search and copy fees due to the Irish G.R.O. will be up to \$10.



### **(5) Direct Ancestors of Martha Williams**

Genealogist recommends applying up to two hours of research time completing a digital collections survey on the direct ancestors of Martha Williams.

*Digital Collections Survey is a term we use to describe a research survey that exhausts all available collections of documents that are published online including but not limited to Ancestry.com and other premium information service databases. Copies of original documentation may include census, vital, military, probate, land and church records; secondary documentation may include copies of record transcriptions, record index entries and published genealogies.*

### **(6) Direct Ancestors of Nunziata 'Nancy' Pistone**

Genealogist recommends applying up to one hour of research time completing a digital collections survey on the direct ancestors of Nunziata 'Nancy' Pistone.

### **(7) Direct Ancestors of George Rowland Barker**

Genealogist recommends applying up to one hour of research time completing a digital collections survey on the direct ancestors of George Rowland Barker.

### **(8) Identity of John Thomas**

Genealogist recommends applying up to fifteen minutes of correspondence time submitting a request to the New Jersey State Archives to search and obtain a copy of an original death registration for John Thomas who died on the 4th of February 1878 in Hoboken.

### **(9) Identity of Mary McGuinness**

Genealogist recommends applying up to one hour of research time completing a digital collections survey on the identity of Mary McGuinness with an emphasis to establish and prove her specific place of Irish origin as well as the identities of her parents.

  - To submit a request to the Irish General Registration to search and if found obtain a copy of an original Irish birth registration for Catherine Joyce
- 5. Digital Collections Survey**, Up to 2 hours research time
  - Research survey on the direct ancestors of Martha Williams that will search all available collections of documents that are published online including but not limited to Ancestry.com premium databases. Copies of original documentation may include census, vital, military, probate, land and church records; secondary documentation may include copies of record transcriptions, record index entries and published genealogies.
- 6. Digital Collections Survey**, Up to 1 hour research time
  - Research survey on the direct ancestors of Nunziata 'Nancy' Pistone that will search all available collections of documents that are published online including but not limited to Ancestry.com premium databases. Copies of original documentation may include census, vital, military, probate, land and church records; secondary documentation may include copies of record transcriptions, record index entries and published genealogies.
- 7. Digital Collections Survey**, Up to 1 hour research time
  - Research survey on the direct ancestors of George Roland Barker that will search all available collections of documents that are published online including but not limited to Ancestry.com premium databases. Copies of original documentation may include census, vital, military, probate, land and church records; secondary documentation may include copies of record transcriptions, record index entries and published genealogies.



**8. Correspondence**, Up to .25-hours correspondence time + up to \$15 record copy fees

- To submit a request to the New Jersey State Archives to search and obtain a copy of an original death registration for John Thomas who died on the 4th of February 1878 in Hoboken.

**9. Digital Collections Survey**, Up to 1 hour research time

- Research survey on the direct ancestors of Mary McGuiness that will search all available collections of documents that are published online including but not limited to Ancestry.com premium databases. Copies of original documentation may include census, vital, military, probate, land and church records; secondary documentation may include copies of record transcriptions, record index entries and published genealogies.
