I agree that you should reach out to ICAP and have ICAP order the following, (A) 1874 Italian birth certificate for Maria 'Mary' Razzano, (2) 1923 Tunsian birth certificate for Mathilde 'Matilda' Josephine Faruggia and (3) 1950 Italian birth certificate for Emma Sereno.

#### **(1) Identity of Maria Teresa Coppola**

I recommend applying up to two hours of research time completing a digital collections survey of Italian civil death registrations recorded in Brienza, Potenza, Italy to find a copy of an original Italian civil death registration for Maria Teresa Coppola who died after 1888, but before 1903. I will adjust the amount of research time applied if her death occurred shortly after 1888 and also if the indexes are useful per year to efficiently review the names of the dead reported each year.

#### **(2) Identity of James 'Vincenzo' De Luca & Mary 'Minnie' Amarando**

I recommend applying up to two hours of research time completing a digital collections survey on the identities of James 'Vincenzo' De Luca and Mary 'Minnie' Amarando to find proof to answer lingering questions regarding their lives over time which will lead to finding vital records that have not been found yet for your Italian dual citizenship application. Some questions that remain unanswered include the date and place of marriage for the couple, the specific date and place of death for James 'Vincenzo' De Luca and the specific date and place of birth for Mary 'Minnie' Amarando.

#### **(3) Vital Records for Italian Dual Citizenship**

I recommend applying up to one hour of correspondence time to put together a specific plan to obtain the remaining vital records related to your paternal ancestors for the purposes of your Italian dual citizenship. The outcome will be a report that will contain links to specific vital records agencies to complete requests to obtain certified vital records for herself back through her paternal line to Italian migrant ancestors Luigi De Luca and Mariagrazia Razzano.
