Summary of Research Results:

Two hours of research time was applied completing a digital collections survey to learn more about the direct ancestors of Nelson Roy Smith with a focus to identify new ancestors and learn more about their identities beginning with his parents Roy Lee Smith and Mable Clarice Neal. The research survey yielded twelve positive results; specifically, a combination of census and military records as well as record index entries related to the direct ancestors of Nelson Roy Smith.

Summary of Research Recommendations:

(1) Identity & Direct Ancestors of Roy Lee Smith

Genealogist completed searches and it was not possible to find digitized marriage and death records for the parents of Roy Lee Smith known as William Decale Smith and Mary Francis Murphy so it has not been possible to verify and prove their respective dates and places of marriage and death. It will be important to submit requests to obtain copies of original marriage and death records for William Decale Smith and Mary Francis Murphy to analyze those records and learn more about the identities of their parents.

The identities of the parents to Mary Francis Murphy were not known at project start and during the last phase of work it was not possible to find original or secondary sources that reported the names of the parents to Mary F. Murphy. It is important to obtain copies of original marriage and death records for Mary F. Murphy Smith as a possible source to establish and prove the identities of her parents. After their identities have been established it will allow genealogist to continue to search for copies of census or other related records to prove their identities.

Although the identities of the parents to William Decale Smith were known a project start genealogist was unable to find census records on William Decale Smith prior to 1900. At that time he resided at the household of his parents or at the home of a guardian. A copy of his marriage and death record will likely report the identities of his parents, which will help the genealogist continue to search for census and other related records on the identities of his parents.

Genealogist recommends applying up to forty-five minutes of correspondence time requesting copies of original marriage and death records for William Decale Smith and Mary Francis Murphy from the States of Mississippi and Louisiana. The record search and copy fees due to the States of Mississippi and Louisiana will not likely exceed \$60.

(2) Identity & Direct Ancestors of Mable Clarice Neal

Genealogist completed searches and was unable to find a digitized birth record or index entry for Mable Clarice Neal to verify and prove her date and place of birth was the 13th of April 1913 in Bastrop, Morehouse County, Louisiana. It was also not possible to find a digitized marriage record or index entry to verify and prove the date and place of marriage to Roy Lee Smith said to have occurred at project start on the 8th of December 1932 in Lucedale, George County, Mississippi. Another research obstacle encountered during the previous phase of work was the inability to locate a 1920 Federal population census on the identity of Mable Clarice Neal when she would have resided with her parents or a guardian at the age of seven.

It was discovered during the previous phase of work that Mable Clarice Neal was raised by foster parents who had the surname 'Duncan' and from a brief description of them in her obituary it seems likely they were a maternal uncle and aunt to Mable. At the end of this phase it was discovered that Henry Nelson Duncan was reported to have been born in Collinston, Morehouse County, Louisiana during 1890 according to his WWI draft registration card from 1917. Genealogist completed searches to locate further information on Annie Clarice Duncan and Henry Nelson Duncan but was unable to find a 1900 census on their identities when they likely would have resided together with parents or guardians. Most of the 1890 census was destroyed by a fire at the Capitol which is why it was not possible to find an 1890 census on their identities.

Genealogist recommends applying up to a half hour of correspondence time requesting a copy of an original birth and marriage record for Mabel Clarice Neal from the State of Louisiana and Mississippi. The search and copy fees due to those states will not likely exceed \$40.

 - To request copies of original marriage and death records for William Decale Smith and Mary Francis Murphy from the States of Mississippi and Louisiana.
- **2. Correspondence**, Up to .5-hours correspondence time + \$40 record copy fees
 - To request a copy of an original birth and marriage record for Mabel Clarice Neal from the State of Louisiana and Mississippi.
